CPR improves the victim's chance of survival by providing heart and brain circulation. Rescuers should perform chest compressions for all victims in cardiac arrest, regardless of rescuer skill level, victim characteristics, or available resources.

**Part 4: CPR Overview | Circulation**  
For the general public or bystanders who witness an adult suddenly collapse: compression-only CPR, or Hands-Only CPR. Hands-Only CPR is CPR without mouth-to-mouth breaths. It is recommended for use by people who see a teen or adult suddenly collapse in an out-of-hospital setting (such as at home, at work, or in a park).

**What is CPR | American Heart Association CPR & First Aid**  
In 2010, the American Heart Association's (AHA) Guidelines for CPR rearranged the order of CPR steps. Today, instead of A-B-C, which stood for airway and breathing first, followed by chest compressions , the AHA teaches rescuers to practice C-A-B: chest compressions first, then airway and breathing.

**Why Did CPR Change from A-B-C to C-A-B?**  
If providing CPR for an infant the ratio of compressions to breaths remains the same but the method of performing compressions changes. For an infant you should use 2-3 fingers in the center of the chest on the lower half of the breast bone to compress the chest about 1 1/2".
